The presentation will include findings of the EDGE committee, status regarding the JNAC recommendations, the financial status of our church, and what the future possibilities are for Westworth and for the Vision of our church. It will also include future steps that are being investigated and currently tried out including youth programming, outreach initiatives, and contacts with other congregations. The message is that any steps taken will take time to accomplish but that we are in a strong position to consider and pursue various options. The meeting must be kept to a timetable.
