  - Westworth should be focussed on commonalities between congregations and communication with congregation members must be very clear at every step.
  - Noreen Mian and Greg Fearns, representatives from St. Andrews River Heights, are presenting the report to SARH Council, also, January 26.
  - We should communicate that we went through this process as an information-gathering experience so that we can better understand our position and have a useful conversation regarding joining together.

8. Business Arising from the Minutes

Gym Redevelopment Committee: Gordon Gray and Barbara Meyers, Independent Consulting, joined the meeting at 8:00 p.m.

Bruce and Keith led this discussion. As the conversation evolved, it was evident the original proposal had changed significantly from the potential of several apartment units built on the gymnasium footprint to 3 private residences built on that same land. Renovations to the remaining Westworth building would be extensive and, depending on needs and choices, could be somewhat expensive. Given these changes – no apartments – the opportunity to have a property management company involved was not available. At this time, the reduced scale of the development would not work for Independent Consulting. The most realistic option for us would be the newest proposal. To consider a multi-family development, Westworth would need to have an internal discussion before we go forward. There would be barriers in the community and with the City Planning Department. Currently the City is suggesting a maximum of 13 units or single-family housing.
