Discussion about whether to, and how to support the Free Press initiative to cover topics of faith ensued, including 1) the possibility of inviting individual donors to contribute; and 2) as ongoing support of this initiative may be best considered and viewed as a 'communication policy (strategy?)' of Westworth,

- ii) Tammy Earnst is to be consulted as to her specific duties in ongoing safety protocols.
- iii) A fee for cleaning following rentals is to be ensured as part of rental agreements.
- iv) Tammy Earnst, Paul Chard and Property Committee, with support of Dianne Sjoberg will work out details of rental agreements to ensure equitable treatment of all interested groups.

(This is an important procedure to work out and have in place as there are ongoing requests for rentals)
