The terms of this full-time ministerial position comply with the standards of remuneration and benefits set by the Executive General Council of the United Church of Canada and Prairie to Pine Regional Council.

**Moving and travel costs** incurred because of a successful candidacy will be reimbursed to a maximum of \$10.000.00.

**Salary**: The salary will be negotiated with the selected candidate based on experience, skill set and years of service in ministry, up to and including salary Category F (cost of living group 4).

**Hours of Work**: This is a full-time position based on a 40-hour work week. Specific duties and work times will be negotiated with the Ministry and Personnel Committee.

**Telephone**: As per Prairie to Pine guidelines at \$ 420.00 per year

**Travel Allowance**: Westworth provides an allowance based on the travel scale rate per kilometer, currently \$0.55, as set by General Council each year.

**Vacation**: Provision shall be made for a vacation of at least one month, to include five Sundays as per United Church standards.

**Study Leave**: The minister may take up to three weeks of paid study leave each year, to be arranged in consultation with the Ministry and Personnel Committee.

**Continuing Education and Learning Resources Allowance**: Westworth provides the continuing education allowance of \$1,543.00 as set by the United Church of Canada.

**Sabbatical Leave**: All full-time Ministry Personnel are entitled to a sabbatical leave, to be negotiated with the Ministry and Personnel Committee. For further details see the Sabbatical Policy for Ministry Personnel in Pastoral Relations (<a href="www.united-church.ca/files/handbooks/sabbatical">www.united-church.ca/files/handbooks/sabbatical</a> policy.pdf).

**Support**: The minister will have a private office and the assistance of an office administrator (35 hours per week)

Pp 4 of the Job Description under heading: C. Compensation and Benefits is amended to align with the Terms of Employment (above).
