Recruitment might also benefit from a mentorship with some students. A Sound System mentorship program will be discussed at Council in the new year, as the original grant application for the new A/V system included involvement of Rossbrook House.
- b) Recognizing volunteers based on feedback from the Leadership Team:
 Council decided to create a "Wall of Gratitude" throughout the Lenten period,
 featuring Westworth volunteers and starting March 9, 2025. This recognition of
 those giving their time and energy would form part of Westworth's Lenten practice.
 Council decided to use the names and groups suggested by the Leadership Team as
 deserving of recognition to kickstart the project, inviting the Community of Faith to

add more paper or foam "hearts of gratitude" with the names of volunteers we wish to publicly acknowledge with gratitude.

c) Budgeting for organ maintenance, per Worship report: The organ should be serviced approximately every two years. Because the Worship Committee budgets for this expense for the piano, they will be asked to include the organ maintenance in their budget in the future. For the current year, the expense will be charged to Worship, and while this team will show an overage this year, the dollars are available within our overall budget to cover the expense.

d) Draft Visioning mandate sent to Council for consideration, per Visioning report: Phases I & 2 of the document reflect the history of the committee. Phase III addresses the mandate going forward.

Discussion points:

- A separate eblast, starting this coming week, will enhance communication with the COF letting them know what Visioning is currently working on.
- Senior programming is up and running, and reports to Visioning.
- Visioning is working to develop the Hub which would include a Daycare, Community Nursing, housing, as well as Senior Programming and Westworth United Church.
- Visioning is working to understand the feasibility of redevelopment, and will convey what they learn to Council and the COF.
- A motion with the new mandate for Visioning will be presented to Council in January and ratified at the AGM in March, 2025.
